On Friday a large meeting of agriculturists in the Depwade Union, was held at the Union-house, Pulham; Mr. J. L. King in the chair. Several speeches were delivered, and resolutions, confirmatory of those passed at the meeting held in St. Andrew's-hall, Norwich, were passed. Mr. King (Diss), Mr. Buckenham (Harleston), and Mr. Rattee (**Hapton**), veterinary surgeons, were recommended to the magistrates as inspectors for their respective districts. Mr. KING said he had at present about twenty cases, and Mr. BUCKENHAM said up to last Wednesday he had had thirty-four cases. The proceedings terminated with the usual vote of thanks to the Chairman.
